From 2007 to 2009, as EVP of Renewable Energies at Schneider Electric, Claude Graff took over the creation and the development of this new business unit. He successfully realized the acquisition of the Canadian company Xantrex (photovoltaic inverters manufacturer) and the development of solutions and services for the group in the solar and wind sector.

Claude Graff started his career at Schneider Electric in 1988 as Director of Marketing and Sales in Paris and coordinated all the national negotiations with EDF , He joined the the UPS division in 1995 as the international director for Asia and Europe to be part of the creation of the new spin-off company MGE UPS Systems in Grenoble ,through a first LBO . He became COO in 1999 and successfully developed and strengthened the activities of MGE and participated to a second LBO In 2002, he became President & CEO of MGE which reached a turnover of \$ 800 million, and employed 4,000 people in more 50 countries at the time of its acquisition in 2005 by the Schneider group.

After joining the Executive Committee of Schneider Electric in 2005, Claude Graff played a leading role in the acquisition of the American leader, APC.

Prior to joining Schneider Electric, Claude Graff held different senior sales positions with the group Merlin Gerin. in Lille, Tours and Paris
